### **Housing Benefit**

You can only make a new application for Housing Benefit if:

- you or your partner have reached the qualifying age for Pension Credit, or
- you were homeless and the council has put you in temporary accommodation.

Some of our working age tenants still get Housing Benefit – but if you apply for some additional benefits, you will be moved to Universal Credit. **See note above.**

### **Priority debts**

Some debts are more important than others. You should always prioritise paying:

- · your rent don't risk losing your home
- your Council Tax you could be taken to court
- your energy bills
- your phone and internet bills
- your TV licence you could be taken to court
- · any overpaid tax credits or unpaid tax
- court fines and unpaid child maintenance, or
- goods bought on hire purchase or similar schemes.

# Government cost-of-living help

### **Energy costs**

### Support for everyone

The Government stopped paying £67 per month towards your electricity bills in April 2023. If you have unused vouchers for your pre-paid meter, you must use them before 30 June 2023. If you have lost or not received vouchers, call your energy provider to get them replaced.

Thankfully, the cap on energy prices is now falling. Standard tariff bills should be lower from July 2023. However, if you have a high fixed rate tariff and/or it rises, you should consider switching to the standard tariff instead.

Because the subsidy has ended, many people will still pay more next winter.

#### **Pensioners**

You will again get an extra £300 on top of your normal Winter Fuel Payment of £100-300. This will be paid in November or December 2023.

### People on benefits

You will get £900 if you claim any of the following:

- Universal Credit
- Child Tax, Working Tax or Pension Credits
- Income-based Jobseeker's Allowance
- Income-related Employment & Support allowance, or
- Income Support.

The money is being paid in three amounts, with payments in the spring and autumn of 2023 and the spring of 2024.

### People with disabilities

You will get an additional £150 in the summer of 2023 if you get:

- Attendance, Constant Attendance, or Disability Living Allowance
- Personal Independence Payment
- Armed Forces Independence Payment
- War Pensioners' Mobility Supplement, or
- Scottish disability benefits.



### Winter fuel schemes

#### Winter Fuel Payments

If you were born by 26 September 1956 and you get a state pension or benefits, you will get a Winter Fuel Payment of £100-300 in 2023. For queries, call the helpline on  $0800\ 731\ 0160$ .

#### **Warm Home Discount**

People on low incomes may get an additional £150 Warm Home Discount taken off their electricity bill. The scheme is currently closed but will reopen in October 2023.

#### **Cold Weather Payments**

When the temperature stays below 0C for seven days during November to March, people on Pension Credit, Universal Credit, and other benefits for jobseekers, get £25 each week towards their higher energy costs.

# Help with water bills

Thames Water has two social tariffs for water.

#### WaterHelp

If you are on benefits, with a London household income below £21,749, WaterHelp cuts water bills by half.

#### WaterSure

WaterSure can also cap bills for people on means-tested benefits. You will need to be on a water meter and use a lot of water, because:

- you have a large family (three or more children), or
- someone in your household has a medical condition that needs extra water (for example, eczema or psoriasis).

# Social tariffs for broadband

Several UK broadband providers have social tariffs for people on Universal Credit and other means-tested benefits.

BT Home Essentials: Various options available. Go to: www.bt.com/exp/broadband/home-essentials, or call in to a BT store with your National Insurance number.

G Network Essential Fibre Optic: 50Mb broadband for £15 a month. Go to: www.g.network/home-broadband/essential-fibre-broadband, phone 0808 196 3661, or email essentialfibre@g.network

Community Fibre: 20Mb full fibre broadband for £12.50 a month. *This deal is open to everyone. You do not need to be on Universal Credit.* 

Virgin Media Essential Broadband: For existing customers on Universal Credit. 15Mb broadband for £12.50 a month or 54Mb for £20 a month. Apply at www.virginmedia.com/help/register-for-essential-broadband

Hyperoptic Fair Fibre: 50Mbps, £15 a month, OR 150Mb, £20 a month (add £3 to either for with evening/ weekend landline calls). Go to: www.hyperoptic.com/broadband/home/price-plans/social-tariff-broadband/

TalkTalk: Six months of free broadband for jobseekers on Universal Credit, who have no internet connection. Ask your Jobcentre Plus work coach.
